ICLR: offers access to ICLR.3: an online research platform that provides access to every case published by the Incorporated Council of Law Reporting for England and Wales, including the English Reports, together with a vast archive of unreported case law and citator information.

TimeBase: offers access to LawOne which gives users comprehensive national legislation coverage in Australia with access to full text legislation across all nine jurisdictions, including amending, subordinate and repealed legislation, Bills, Explanatory Memoranda and Second Reading Speeches along with detailed legislative histories and curated cases.

Justis/VLEX: offers JustisOne access to UK case law and legislation, Irish Law, EU Law, Canadian Case Law, Australian Case Law, New Zealand Case Law, Human Rights and many more.
